The Will of Sarah MILLS

Lytchett Matravers 1841

Transcribed and donated to the Dorset OPC Project by Ros Dunning

This is the last Will and Testament of me **Sarah Mills** of Lytchet Matravers in the County of Dorset Spinster made and published this first day of September in the Year of our Lord one thousand eight hundred and forty one I give and bequeath to my Executors hereinafter named the sum of one thousand and three hundred pounds stock now standing in my name in the Books of the Governor and Company of the Bank of England Upon Trust to Pay and Apply the interest dividends and annual proceeds thereof unto and between my **Brother John Mills** of Andover in the County of Hants Gentleman and my **Sister Elizabeth Tatchell** of Yeovil in the County of Somerset in equal parts shares and proportions share and share alike for and during the terms of their natural lives And in case of the decease of either of them the said **John Mills** and **Elizabeth Tatchell** I direct that the share of him or her so dying shall not go to the Survivor but that my Executors do cause the said share of him or her so dying as aforesaid and all the interest dividends and annual produce to arise therefrom & become due thereon to be invested in my name of my Executors in the public funds or on Government or real securities in the United Kingdom And from and after the decease of the survivor of them the said **John Mills** and **Elizabeth Tatchell** I direct my Trustees to pay or transfer the said stock monies and securities and the dividends thereof unto and equally among my nephews and niece (that is to say) to my **niece Elizabeth Tatchell** now residing at Yeovil aforesaid Spinster and to my nephews **John Mills William Mills James Mills Charles Mills and Henry Mills** all of the City of London in equal parts shares and proportions share and share alike or the issue of any or either of them who shall die leaving issue such issue to take only their parents parts And as to all the Rest Residue and Remainder of my real and personal estate whatsoever and wheresoever and of what kind soever I give and bequeath the same unto and amongst my said nephews and niece in equal parts shares and proportions share and share alike for their own absolute use and benefit respectively And I hereby nominate and appoint my two nephews **John Mills** and **James Mills** to be Executors of this my Will And I hereby direct that it shall be lawful for my said Executors respectively by and out of the monies which shall come to their or his hands respectively to retain or allow to each other all costs charges damages and expences which they shall respectively sustain or expend in or about the execution of the trusts or in relation thereto In Witness whereof I the said **Sarah Mills** have to this my last Will and Testament set my hand and seal this said first day of September one thousand eight hundred and forty one **Sarah Mills**

This is a Codasal to my Will April 27 1842 I direct my Executors to sell this house and the land that is atachd to it with the books furniture and the money to be bought in the funds after all expences are paid I desire to be buried in the plainest manner posabel I give to my sister **Elizabeth Tatchell** all my pleat linnen and wearing apparel and books and I desire that my **brother John** do not come hear if he do he is to forfit all claim to his part of the property if any of the family this pleas and likes to have the Clock they are to pay **Elizabeth** three Guines as half the Clock is hers and I desire that she have mourning I desire that **Elizabeth Tatchell** do have her mother's part paid to her during the life of my **brother John Sarah Mills** Signed sealed and delivered this fifth of May one thousand eight hundred and forty two **George Frampton Henry Frampton**
